ORDER

WHEREAS, the institution namely **K.R.P. College of Education, Pachampalayam, Padaiveedu, Sankari West, Namakkal District-637303** was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/M.Ed./2006-2007/13463 dt. 24.10.2007 for conducting M.Ed. course of one-year duration with an annual intake of 25 students. The consequent upon the notification of the National Council for Teacher Education (Amendment) Regulation, 2010 on dt. 26.07.2010 the intake of existing 25 students in M.Ed. course was increased from 25 to 35 vide SRC, NCTE order dt. 24.08.2010.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution by a notarized affidavit dt. 29.05.2015 consented to come under new Regulations.

3. **AND WHEREAS**, the Southern Regional Committee (NCTE) issued the Revised Provisional Recognition order was issued to the institution on 31.05.2015 for conducting M.Ed. course of two years duration with an annual intake of 50 students (one unit) from the academic session 2015-16. Thereafter, the institution submitted its reply along with documents on 26.03.2018 & dt. 11.01.2018 in compliance of Show Cause Notice dt. 27.12.2018 and dt. 30.06.2019. Thereafter, the SRC in its 384th Meeting held on 12th & 13th February 2020 and decided to issue a final show cause notice (FSCN). Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on dt. 24.02.2020. Thereafter, a reply of Final Show Cause Notice was received on dt. 11.03.2020.

4. **AND WHEREAS**, the complicate submitted by the institution was considered by the SRC in its 388th meeting held on 14th -15th September, 2020 and committed decided as under: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

On the perusal of the reply submitted by the institution vide letter dt 11.03.2020, the Committee decided that the **continuation order** be issued to the Institution **K.R.P. College of Education, Namakkal District, Tamilnadu-637303** for following existing courses: -

- (i) **B.Ed - 2 units (50 students each unit).**
- (ii) **M.Ed- 1 unit of 50 students.**

5. **NOW THEREFORE**, this order is issued permitting the institution **K.R.P. College of Education, S.F.No.178/2B1B&178/2B2 Padaiveedu Town Panchayat, Pachanpalayam, Padai Veedu Post, Sankari West, Namakkal District, Tamilnadu-637303** or continuation of conducting M.Ed. course of two years duration with an intake of 50 students (one basic units of 50 students) subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation form the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

6. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.

7. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

8. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;

- i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
9. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
10. The institution shall make available the list of students admitted on its official website.
11. The institution shall fill the information on GIS Portal on the NCTE Website. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued thereunder, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
